The meeting was called to order at 8:34 A.M. All commenced in the Pledge of Allegiance.

# Administrator Report:

Mrs. Harper reported that the school has been doing summer hiring and has filled all open teaching positions. They are still looking to hire more aides. The coming school year will have masks optional, not required. Sports should also be back to normal. A decision will be made at the Reid board meeting on the evening of July 1<sup>st</sup> as to whether the school will remain hybrid (with an option for in-person or online learning) or return to in-person only. Mrs. Harper mentioned that the percentage of parents who wanted an online learning option was very low.

# President Report: Elizabeth Brown

Elizabeth reported on the following topics:

- The EduKit school supplies will be delivered to the school by the end of July for parents that ordered them.
- There have been discussions in the past about having evening PROP meetings for parents who cannot attend in the morning. Elizabeth proposed an idea about having quarterly PROP Zoom meetings in the evening in addition to the normal meetings. These would not be official meetings but would be more of a summary of PROP happenings to keep parents up to date. The consensus was positive, and all seemed to be in favor of the idea.

- PROP will need volunteers at the Meet the Teacher night (2 P.M.- 4 P.M.) to sell used uniforms, spirit shirts, pass out flyers, and possibly recruit volunteers.
- Elizabeth talked about having all of the PROP information available on the PROP website (propaz.org) so fewer flyers and handouts need to be printed and distributed for the beginning of the year.

# Secretary Report: Elizabeth Kiss

Elizabeth Kiss was not in attendance. The minutes from the May PROP meeting were not completed and available. There was also not a quorum for voting. Elizabeth Brown said that an email would go out to vote at a later date.

# Treasurer Report: Claudia Mocan

Claudia reported that PROP has \$19,028 in the bank with another \$448 to be deposited soon. Per PROP Bylaws, we are to carry over no more and no less than \$10,000.00 to the next Fiscal Year (which begins August 1<sup>st</sup>). Claudia also reported that she and Elizabeth Brown are still working on the proposed 2021/2022 Budget which will be email out for a vote once complete. She also has the reconciliation report available for review.

To spend the excess \$9,476, the following ideas were proposed:

- Personalized Large Door Mat (with PRA name/ logo)- suggested by Mrs. Harper. Cost around \$500
- Recycling bins for in the classrooms/ recycling dumpster- suggested by Mrs. Harper who needs to look into the details. Not sure if there is a cost.
- Gift Cards to incentivize teachers who decide to become Spalding certified- suggested by Mrs. Harper. Not sure of cost.
- Updates to the Teachers Lounge to include new chair covers, pictures, plants, small couch, and lamps. Suggested by Mrs. Harper. Not sure of cost.
- New Spirit Shirts to include the phrase "Celebrating a Decade of Excellence"- suggested by Mrs. Harper. Cost would come out of Hawk Pride budget for Spirit Shirts.
- Donations of books and games for Boulder Club- suggested by Mrs. Harper. No cost. Would just need some active advertising. Someone suggested asking for donations at the Book Fair.
- \*Off Topic\*- someone asked about spraying for ants. Mrs. Harper said that they have monthly pest control, but she would have maintenance look into the ant issue.
- A new PROP room computer, an updated Quicken program, & printer because the current ones are old and starting to have issues- suggested by Claudia Mocan. Cost TBD. Colleen Hubbard offered a donation of a printer that she had given to her.
- A mini fridge for the PROP room to store cold items for meetings & events- suggested by Claudia Mocan. Cost TBD.
- A small safe to secure money- suggested by Claudia Mocan. Cost TBD.
- A Keurig coffee make for the PROP room- suggested by Claudia Mocan. Cost TBD. Both Danielle Phillips and Jenna Andrade said they would see about possibly donating an extra one.

Suggested items will be emailed out for a vote on spendings.

Elizabeth Brown did mention that \$2000 of the \$9000+ will go to Reid toward the Marquee fund.

Mrs. Harper gave an update on the 2021 8<sup>th</sup> grade promotion. She said that everything went well. It was held in the school parking lot. Students came up on the risers one at a time to get pictures taken and parents & teachers watched from the parking lot.

#### The floor was opened discussion:

Elizabeth Brown mentioned that the new benches for the basketball court were finally installed in May (over a year after purchase).

Someone asked about setting up a day or days to come in and clean up the PROP room. Elizabeth said she would figure out a day and email everyone the information.

The meeting was adjourned by Elizabeth Brown at 9:18 AM.
